# LOOKING BACK

I hope you have had an enjoyable Festive Season with friends and family. As we begin a new year, we reflect on what the year has been like for us, personal successes, failure, hopes, dreams, aspirations fulfilled or not and most importantly what the future holds for us as pensioners in the future.

The last year has been dominated by Brexit to the exclusion of the real issues which have impacted on the health, well being and financial security of communities across the country as a result of 10 years of Austerity. We've seen the Windrush scandal and the shame of the 34 000 winter deaths as a result of cold related illnesses. Loneliness is escalating. Pensions remain one of the lowest in the developed world. Our television licence and concessionary travel are under threat. The NHS remains grossly underfunded with doctors forced to take industrial action over patient safety caused by staff shortages and real terms underfunding. The social care system is failing to meet the needs of those who need it most. Cuts to Local Authority have left councils introducing cuts to staffing and essential services.

Homelessness amongst young and old abound with some people found dead on the streets of Britain last year. 330 000 among them children are now without a permanent home. The vast majority of working people have seen their income fall in real terms. 70% of those receiving benefits are in work. Universal credit has left thousands without access to food. The Trussell Trust reported the highest levels of food banks on record.

The crisis in our schools are so severe that 2 000 Head Teachers marched on Downing Street. These are just some of the challenges facing communities across the country. As a pensioner's action group campaigning for improvement to the quality of life of todays and tomorrow's pensioners, we need to continue our efforts to build a strong, viable and effective group which will confront the challenges and campaign for real change.

#### **PROFITS BEFORE CARE**

An investigation by the Guardian has found that companies which own homes that have been rated inadequate, the lowest possible rating by the Quality Care Commission (CQC) are raking in millions in profits. These homes care for elderly people with Dementia, disabled people and those with learning difficulties. Of the 220 homes rated inadequate by recent inspections are turning over millions of tax free profits at least 44 were owned by private companies. Amongst some of the atrocities inspectors found were too few staff to meet patients' needs; medicines not safely managed; patients at risk from dehydration and malnutrition; dirty and unkempt rooms and staff failing to uphold residents' treatment with dignity and respect.

Barbara Keely Shadow Minister for Social care is reported as saying: 'This investigation has exposed the appalling standards of care being provided by some of the largest providers of outsourced residential care which has left large numbers of vulnerable people in need of care suffering terrible indignity and neglect.'

The long awaited Green Paper on Social Care has still not been released. When released the NPC will again press its demand for a Social Care System funded through general taxation, free at the point of delivery and staffed by fully trained, fairly paid and care homes scrupulously monitored to deliver quality care which will meet the diverse needs of people in care.
