### LAMBETH EQUALITY COMMISSION

**Speaker: Cllr Winifred Cabinet Member for Culture and Equalities**

Lambeth is one of the most deprived areas in the country. It is the 8<sup>th</sup> most deprived borough in the country and the 22<sup>nd</sup> most deprived in the communities. Some of the communities suffer great levels of poverty and inequality and face barriers that prevent them from reaching their potential. In 2017 Lib Peck, then leader of Lambeth Council set up Lambeth Equality Commission. Their task was to identify the barriers which stand in the way of equality of many especially the most marginalised and then to work at breaking them down.

This is your opportunity to come and be part of the debate on **who** the members of the Commission are, **how** they were identified, of **how** the Commission collected evidence of the **extent** of inequality and unfairness in the borough, **what** strategies, projects, programmes have been put in place to tackle these. Furthermore, we would like to know about **the outcomes** so far, **what more** needs to be done and differently if need be, **by whom** and **how**.

Of special interest to us as pensioners who experience extremes of pensioner and fuel poverty resulting in unnecessary cold related deaths, whose social care needs are often not met, who have problems with inadequate and suitable housing, who experience loneliness and social isolation as a result of cuts to essential older people's services and to universal benefits which in turn affect their health and wellbeing, we need to know what actions the Equality Commission has taken and plan to take to combat inequality and unfairness across the Lambeth older community.

We are also keen to learn about the Cabinet member's work with organisations in the borough's arts and cultural communities as well as her oversight of sports and leisure.

Workers have campaigned vociferously and strongly against the rich and powerful and for the unity of the young and old and men and women equally. The call is for Trade Union rights, equality, social justice and international solidarity all now under threat because of the Austerity agenda and Brexit. As retired workers ourselves, LAMPAG will be joining workers at the May Day rally in solidarity with the workers.

### BREXIT AND OLDER PEOPLE

Since the Referendum in June 2016, there has been a stream of parliamentary debates, discussions and votes to the exclusion of the real issues which affect communities across the country. Theresa May's withdrawal deal has been rejected three times by large margins and at the time of writing we still do not know the end product. There are a number of specific issues directly affecting pensioners.

**The state pension** is uprated for British recipients in European Economic Area countries or where there is a reciprocal social security agreement. Until the UK formally leaves the EU the existing social security rules therefore continue to apply and entitlements remain unchanged. However, it is important to note that this is not yet part of the final agreement putting pensions rights and the triple lock in danger as a result. There are concerns around **health and care** regarding the uncertainty amongst the workforce. Over 60,000 people from EU countries outside the UK work in the NHS in England and around 90,000 in adult social care. There is no doubt the UK's health and social care sectors rely on overseas workers so it is important that the employment and residency rights of these people are not undermined during and after Brexit. Data from the Nursing and Midwifery Council has shown a substantial reduction in the number of applicants to the nursing register from EU nationals since the referendum. There is a danger that in the current form of the withdrawal bill, **the EU Charter on Fundamental Rights** will not apply in Britain post withdrawal. This has implications for UK anti-discrimination law. Under EU rules **VAT** has to be added to **energy bills**, at present 5% following the NPC campaign. However, under a new arrangement, this requirement would no longer apply. This despite the recent increases in energy prices. Should a **hard border** between Northern Ireland and the Republic of Ireland happen, this will put travel across the two countries at risk. There are also indirect consequences of Brexit which affect us all, like the impact on the economy and reduced trade, businesses relocating to Europe or shutting resulting in job losses and insecurity, concerns about drugs and food shortages, and European Health Insurance. For now there is a sense of genuine powerlessness
